E-services to facilitate licence applications for trade related to the Business Liaison Groups

Purpose

This paper briefs members on the e-services provided by relevant government departments for licence applications.

Background

2. To provide more convenient licence application services, relevant government departments have provided e-services for a number of licences under the "Be the Smart Regulator" Programme to facilitate the trade to handle licence applications in a speedy manner. These services include e-submission, e-payment, and e-licence. Among them, the e-services provided by the Food and Environmental Hygiene Department (FEHD), the Home Affairs Department (HAD) and the Hong Kong Police Force (Police) to facilitate the trade to apply for licences for operating relevant premises or holding specific commercial activities in their premises have benefited a variety of trades related to the Business Liaison Groups, such as recreational clubs, entertainment clubs, family amusement centres, cinemas, hotels and guesthouses, etc.

Details of the e-Services

E-services for premises-based licences

3. Premises-based licences include the Club-house Certificate of Compliance (CoC) issued to premises of recreational clubs, entertainment clubs (such as mahjong clubs) etc., Hotel / Guesthouse Licence issued to premises of hotels / guesthouses, and the Amusements with Prizes Licence (AWPL) (Annual / Short-term) issued to premises of family amusement centres by HAD; and the Places of Public Entertainment Licence (PPEL) (Cinemas / Theatres) issued to premises of cinemas / theatres by FEHD. Details of the e-services are summarised in the tables below -

A. Club-house CoC, Hotel / Guesthouse Licence, AWPL (Annual / Short-term)

E-services for event-based licences

4. Event-based licences include the Temporary Liquor Licence issued by the Police for the retail sale of liquors at any public entertainment or on any public occasion, or for wine tasting event; the Trade Promotion Competition Licence issued by HAD for promoting, conducting and managing a competition or scheme for the purpose of promoting a trade/business/product sale by way of a game that distributes or allots prizes by lot/chance (such as the lucky draws conducted by department stores, supermarkets and chain stores to promote business); and the Temporary PPEL issued by FEHD for holding temporary public entertainment events in premises such as theme parks and shopping malls. Details of the eservices are summarised in the tables below —

C. Temporary PPEL

Moreover, HAD, FEHD and Police have also provided online application tracking services for the above-mentioned licences (except for AWPL, Temporary PPEL and Trade Promotion Competition Licence) to enhance transparency so that the applicants could keep track of the application progress (such as whether comments are already provided by other government departments concerned to the licensing authorities and the issuance of the Letter of Requirements, etc.) and respond to department's requests in a timely manner, which in term will expedite the licensing process.
- 6. The above-mentioned e-services not only allow the applicants to submit applications anytime and anywhere through different electronic devices, but also

enhance the flexibility in filling in the application forms which can be saved and retrieved at the applicant's choice. Furthermore, as most of the supporting documents can be submitted online in one-go, it reduces the cost and administrative burden to the trade arising from submission by post or in person and at the same time is more environment-friendly. Payment of fee and collection of licence have become more convenient to the applicant as it is no longer necessary for him/her to visit the department's service counter in person, and hence enhancing the user experience while saving the time and cost incurred by the applicant.
