 - (a) Wilfully disseminating, circulating, publishing or re-publishing on any internet-based platform or medium (including but not limited to LIHKG and Telegram) any material or information for the purpose of promoting,

encouraging or inciting the use or threat of violence, intended or likely to cause:-

- (i) bodily injury to any person unlawfully within Hong Kong; or
- (ii) damage to any property unlawfully within Hong Kong.
- (b) Wilfully assisting, causing, counselling, procuring, instigating, inciting, aiding or abetting others to commit any of the aforesaid acts or participate in any of the aforesaid acts.

IT IS FURTHER ORDERED that :-

- 2. Leave to the Plaintiff to serve this Order on the Defendants by way of substituted service, by publishing a copy of this Order on the websites of the Hong Kong Police Force as well as that of the Government of the Hong Kong Special Administrative Region;
- 3. The Plaintiff be given leave to redact any part of the materials filed in the Registry which reveals the personal particulars of any Police Officer and/or their family member(s);
- 4. No person may, without leave of the Court, search for, inspect or copy the documents filed in the Registry in this action;
- 5. Costs of the Plaintiff's Summons be reserved; and
- 6. There be no order as to costs in respect of the ISOC's Summons.
