#### Proposed Implementation Details of the Registered Fire Engineer Scheme

#### **Purpose**

This paper briefs Members on the proposed implementation details of the Registered Fire Engineer (RFE) Scheme (the Scheme).

#### **Background**

- 2. To facilitate business operation and make better use of qualified professional in the market, the Fire Services Department (FSD) proposes to introduce the Scheme. Under the Scheme, RFEs will be allowed to provide fire risk assessment and certification services which are currently only provided by FSD for applications of licences of specified premises (please refers to paragraph 5 for details). This will provide greater flexibility to these applicants.
- 3. The implementation of the Scheme requires legislative backing. The enactment of Fire Services (Amendment) Ordinance 2017 by the Legislative Council (LegCo) in March 2017 has provided the basis for the making of subsidiary legislation for the Scheme (the New Regulations). Our plan is to set out the implementation details in the New Regulations. The New Regulations will be subject to positive vetting by LegCo<sup>1</sup>.

#### **Proposed Governance of the Scheme**

4. Regulation over RFEs will be enforced at several different levels. Firstly, a rigorous set of qualification and experience requirements will be put in place to ensure that only those who fully qualify may enter the trade. Secondly, FSD will issue codes of practice and guidelines to the RFEs to guide the latter's performance of duties, and strict compliance will be required. Thirdly, to ensure consistent fire safety standards will be applied, FSD will require that fire safety requirements formulated by a RFE must be endorsed by the FSD before they are issued to the licence applicants. In addition, to ensure quality of certification work of the RFEs, FSD will conduct audit inspections of at least 70% of the

certification completed at the initial stage of implementation of the Scheme. Finally, a disciplinary mechanism will be set up to deal with cases in which a RFE is suspected to have failed to discharge his/her duties properly. Such principles of the regulatory regime were supported by the Bills Committee when the Fire Services (Amendment) Bill was discussed.

### **Implementation Details**

#### (A) Applicable Premises

5. The Scheme will apply in phases to the premises listed at <u>Annex</u>, which include all premises requiring a licence or its equivalent to operate and for which FSD has been providing fire risk assessment and certification services during the licensing process<sup>2</sup>. They are referred to hereafter as 'licensed premises'.

#### (B) Classes and Duties of RFEs

- 6. RFEs will be categorised into three classes in view of the different natures of duties they will be performing and the different professional skills required
  - (i) **RFE** (**Risk Assessment**) (**RFE**(**RA**)) who may conduct fire risk assessments and formulate fire safety requirements for licensed premises;
  - (ii) **RFE** (**Fire Service Installation**) (**RFE**(**FSI**)) who may conduct compliance inspections and testing of any fire service installation or equipment, to verify if the premises have complied with the fire safety requirements (except those relating to ventilating systems) in licensed premises and issue fire safety certificates upon confirmation of compliance; and
  - (iii) **RFE** (**Ventilating System**) (**RFE**(**VentS**)) who may conduct compliance inspections and testing of fire safety features with respect to the ventilating system, to verify if the premises have complied with the relevant fire safety requirements in licensed premises and issue fire safety certificates upon confirmation of compliance.
- 7. A person may apply to be registered as one or more classes of RFE. To prevent conflict of interest, if a RFE provides certification services for fire

It also does not include private columbaria and e-waste disposal facilities, as the licensing schemes for these facilities are newly established and FSD considers it prudent for it to be the only authority to perform the risk assessment and compliance certification services. The list of applicable premises will be reviewed after the Scheme comes into operation for two years.

service installations or ventilating systems for certain licensed premises (i.e. in his/her capacity as RFE(FSI) or RFE(VentS)), he/she must not be the proprietor, shareholder, director, partner or employee of the contractor responsible for the related works. An RFE must also provide a positive declaration of no conflict of interest on each occasion of certification.

#### (C) Eligibility Criteria

- 8. A RFE is expected to possess the relevant professional qualifications, academic qualifications and work experience in order for him/her to discharge the duties competently. An applicant may seek registration as a RFE through one of the following routes
  - (i) he/she is a Registered Professional Engineer (RPE) under the Engineers Registration Ordinance (Cap. 409)<sup>3</sup> in a discipline relevant to fire risk assessment or compliance checks of fire service installations or ventilating systems. He/she should possess at least one year's relevant working experience;
  - (ii) he/she holds a bachelor's or higher degree relevant to the duties of the three RFE classes (e.g. degrees in fire engineering, structural engineering, civil engineering, building services engineering, building surveying). He/she also needs to have completed courses relating to the class of RFE he/she applies for (such as fire science, fire protection systems, fire safety legislation) during the course of his/her degree programme or through recognised top-up courses. He/she should possess at least six years' relevant working experience; or
  - (iii) he/she is a practitioner with at least 15 years' relevant working experience and has completed the recognised top-up courses as mentioned in paragraph 8(ii).

#### (D) Registration Mechanism

9. A Registration Committee will be set up to advise the Director of Fire Services (D of FS) on the operation of the Scheme and the detailed qualification criteria for registration of RFEs (for instance the top-up courses that would be recognised for the purpose of registration as RFEs). An Interview Board will also be set up to conduct professional interviews with the applicants and make recommendations to D of FS as to whether to register the applicants. Each

registration of a RFE will be valid for up to five years and is renewable. Members of the Registration Committee and Interview Boards will be appointed by D of FS, and composed of FSD officers and members of the relevant professional bodies and the academia as appropriate.

#### (E) Issue of Codes of Practice and Guidelines

10. D of FS will be empowered to issue codes of practice and guidelines to the RFEs in order to provide practical guidance on fire safety risk assessment, as well as inspection and certification of fire service installations and equipment and ventilating systems. On the other hand, rules of conduct to be observed by RFEs and acts that could be subject to disciplinary offences will also be listed in the codes. RFEs are required to comply with the codes and guidelines.

#### (F) Disciplinary Mechanism

- 11. The proposed disciplinary offences applicable to RFEs include
  - (i) committing misconduct or neglect in any professional respect;
  - (ii) failing to discharge the duties or abide by the requirements under the New Regulations;
  - (iii) as a RFE(FSI) or RFE(VentS), deviating from the fire safety requirements issued by FSD or a RFE(RA) when certifying compliance for any licensed premises;
  - (iv) failing to notify D of FS, without reasonable excuse, within a specified period after a change in his/her professional qualification that affects his/her fulfilling the requirements for registration;
  - (v) obtaining registration or renewal of registration by fraud or misrepresentation; or
  - (vi) committing a criminal offence under the New Regulations.
- 12. Disciplinary Boards will be set up to inquire into and deal with cases in which a RFE is suspected to have failed to discharge his/her duties properly. If a disciplinary offence against a RFE is established, the Disciplinary Board may order the RFE to be reprimanded, or de-registered temporarily or permanently. Appeal Boards will be established to handle appeals.

# (G) Registration Fees

13. The registration fees for RFEs will be formulated in accordance with the established 'cost-recovery' and 'user pays' principles.

#### (H) FSD to maintain its current services

14. The purpose of introducing the RFE Scheme is to offer an additional option for the licence applicants with a view to facilitating business operation. In other words, licence applicants may still choose FSD to provide fire risk assessment and certification services.
