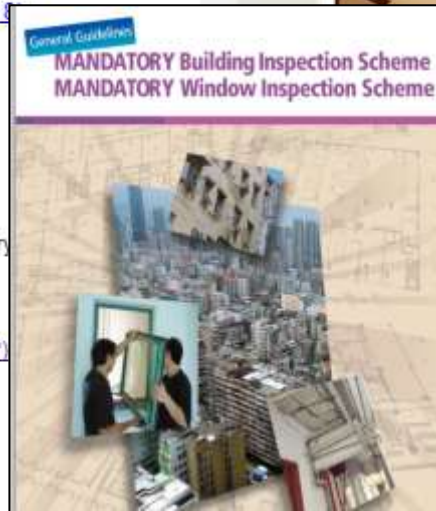

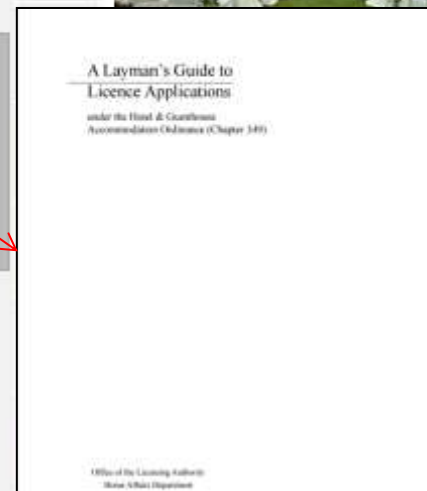

經修訂的《規例》第20(3)條的條文如下：

**20. 牌照的發出及有效期**

(3) 酒牌的有效期為2年，或為酒牌局所決定的較短期間，並由酒牌批出的日期或酒牌局所決定的其他較後日期開始。
