- Public subsidy only when justified
- 只在合理依據的情況下提供公帑資助
- Forestall cost recovery items to be heavily subsidised
- 避免對“用者自付”收費項目作出大幅補貼

# Background 背景

- Same fees are charged for services requiring great disparity in **complexity** and **efforts** required
- 有些服務在**複雜性**和**工作量**方面存在甚大差距，卻收取相同費用
- Obsolete fee structure engendered in the era of ex-Urban Council and ex- Regional Council, which **no longer reflects fully the relative costs**
- 前市政局和前區域市政局時代所訂立的收費制度不合時宜，**未能反映相對成本**

- FEHD conducted an in-house **costing** exercise
- 食環署進行內部**成本計算**工作
- Overall cost recovery rate for liquor licensing services is **only 38%**
- 酒牌服務的整體成本收回率**只達38%**
- Subsidy by taxpayers of around **\$24 million** per annum
- 每年由納稅人補貼約**2,400萬元**

# Current Position 目前情況

- Absence of fee adjustments over the past two decades
- 過去二十年沒有調整收費
- Propose to rationalise the fee structure, better reflect the relative cost
- 建議優化收費制度，準確反映相對成本
- Based on the rationalised fee structure , projection of the estimated fees at the 2017/18 price level

## 可能的影響/紓緩的安排

- About **17%** liquor-licensed premises with bar endorsement. A small increase in renewal fees are expected.  
(For liquor licence with bar endorsement, \$1,170 or \$875 a year on average, or **\$97.5 or \$72.9 monthly**)
- 約**17%**領有酒牌處所是有酒吧批註，牌照續期費用只會稍微增加  
(如酒牌有酒吧批註, 平均每年1,170元或875元，或平均**每月97.5元或72.9元**)
- May implement the fees adjustment on an **incremental basis** to **alleviate** the impact on the trade, e.g. recovering full cost **in two years.**

# Measures to Improve Efficiency & Cut Costs

## 提高效率和降低成本的措施

- FEHD implemented LL Processing System in 2009 and LLB has implemented the following measures between 2013 and 2017 –  
食環署在2009年落實採用處理酒牌電腦系統，酒牌局在2013年至2017年期間實施下列措施：
  - a) Extending the duration of a LL from one year to **two years**  
酒牌有效期由一年延長至**兩年**
  - b) Allowing the submission of application forms electronically either by **assigned passwords** or digital certificates  
接受電子方式**以獲編配的通行密碼或數碼證書**提交申請表格
  - c) introducing an optional "**reserve licensee**" mechanism  
推行非強制性的"**後備持牌人**"制度

# Measures to Improve Efficiency & Cut Costs

- d) Publishing on the LLB website a set of **Guidelines** in the interest of enhancing transparency  
在酒牌局網站**公布指引**，述明審批酒牌申請時所考慮的因素，以提高透明度
- e) Allowing the licensee to submit renewal applications between 3 and 4 months prior to expiry of LL so that the licensee would have sufficient time  
容許持牌人於酒牌有效期屆滿**前三至四個**月提交續牌申請，以便持牌人有充分時間
- f) Setting out the procedures of processing “**application of transfer of liquor licence without the consent of the existing licensee**”  
訂立處理“未有原持牌人同意下的酒牌轉讓申請”的程序

# Measures to Improve Efficiency & Cut Costs

- In the coming years,
  - further streamlining and facilitation measures will be explored and proposed
  - to better the service to the trade and reduce costs, for instance, further development of e-service to LL **through an online service system.**
- 我們日後會
  - 研究和建議更多簡化和利便營商的措施，
  - 為了向業界提供更優質的服務和減低成本，例如**經現時網上服務系統**以進一步推展酒牌方面的電子服務。
