- Applicants shall furnish to Liquor Licensing Board (LLB) in the application form:
 - Two referees who will be able to testify that the applicant is a "fit and proper person" for holding a liquor licence;
 - Two referees are required to sign on the "References for Applicant" in the application form.
- In cases of electronic application, the referees are required to submit their digital signatures.

Waiving Requirement for Referees' Signatures

Since June 2013, the application forms for new issue, renewal and transfer of liquor licence and club liquor licence are revised:-

- Signature requirement for two referees are dispensed;
- Applicant is still required to provide the personal information of the two referees, such as name (Chinese and English), correspondence address, telephone number and the period of acquaintance in the application form for inspection by LLB and the Police.


