## Fully implemented on 14 Dec 2015

- Introduction of new categories of building uses;
- enhancement of the standards for the provision of female sanitary fitments;
- rationalisation of the standards for restaurants; and
- other technical amendments and drafting changes.

Applicable to plan approval of new buildings and major alteration in existing buildings, e.g. change in use or extension




